

**CONTRACT AGREEMENT FOR THE
CONSULTANCY SERVICES FOR THE CONSTRUCTION MANAGEMENT
AND SUPERVISION OF THE HORIZONTAL INFRASTRUCTURE PROJECT
OF THE CLARK INTERNATIONAL AIRPORT
NEW TERMINAL BUILDING PROJECT
(FORMERLY CLARK AIRPORT LOW COST TERMINAL)**

THIS AGREEMENT, made this 29th day of November 2018 between **CLARK INTERNATIONAL AIRPORT CORPORATION** of Corporate Office Building, Civil Aviation Complex, Clark Freeport Zone, Philippines (hereinafter called the "**Entity**") and **JV BETWEEN PHILIPPS TECHNICAL CONSULTANTS CORP. AND DESIGN SCIENCE, INC.**, of 8/F España Tower, 2203 España Blvd. corner Josefina St., Sampaloc, Manila (hereinafter called the "**Consultant**").

WHEREAS, the Entity is desirous that the Consultant executes the **CONSULTANCY SERVICES FOR THE CONSTRUCTION MANAGEMENT AND SUPERVISION OF THE HORIZONTAL INFRASTRUCTURE PROJECT OF THE CLARK INTERNATIONAL AIRPORT NEW TERMINAL BUILDING PROJECT (FORMERLY CLARK AIRPORT LOW COST TERMINAL)** (hereinafter called the "**Consulting Services**") and the Entity has accepted the bid for **SIXTY FIVE MILLION EIGHTY EIGHT THOUSAND PESOS AND 00/100 (PHP65,088,000.00)** (hereinafter called the "**Contract Price**") by the Consultant for the execution and completion of such Consulting Services and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
 - (a) General and Special Conditions of the Contract;
 - (b) Terms of Reference;
 - (c) Request for Expression of Interest;
 - (d) Instruction to Bidders;
 - (e) Bid Data Sheet;
 - (f) Supplemental/Bid Bulletin;
 - (g) Bid form including all the documents/statements contained in the winning bidder's bidding envelopes;
 - (h) Eligibility requirements, documents and/or statements;
 - (i) Performance Security;
 - (j) Notice of Award of Contract and winning bidder's "Conforme" thereto; and
 - (k) Negotiations between CIAC and JV BETWEEN PHILIPPS TECHNICAL CONSULTANTS CORP. AND DESIGN SCIENCE, INC..

3. In consideration of the payments to be made by the Entity to the Consultant as hereinafter mentioned, the Consultant hereby covenants with the Entity to execute and complete the Consulting Services and remedy any defects therein in conformity with the provisions of this Consultant in all respects.
4. The Entity hereby covenants to pay the Consultant in consideration of the execution and completion of the Consulting Services, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.


