

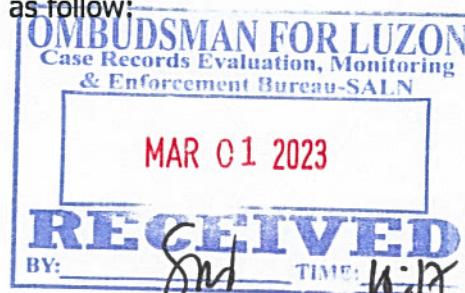


## CERTIFICATION OF COMPLIANCE SALN Submission / Filing
