CONTRACT AGREEMENT FOR THE SUPPLY, DELIVERY AND INSTALLATION OF VARIOUS FURNITURE AND FIXTURES FOR CIAC

THIS AGREEMENT, made this 8th day of January 2018 between **CLARK INTERNATIONAL AIRPORT CORPORATION** of Corporate Office Building, Civil Aviation Complex, Clark Freeport Zone, Philippines (hereinafter called "**CIAC**") of the one part and **FB CARPET & DESIGN SYSTEM** of No. 61 Rosal St., Lumang Bayan Executive Village, Bgy. NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - (a) General and Special Conditions of the Contract;
 - (b) Technical Specifications;
 - (c) Invitation to Bid;
 - (d) Bidding Documents (ANNEX A);
 - (e) Supplemental Bid Bulletin;
 - (f) Bid form including all the documents/statements contained in the winning bidder's bidding envelopes (ANNEX B);
 - (g) Eligibility requirements, documents and/or statements (ANNEX C);
 - (h) Performance Bond;
 - (i) Net Financial Contracting Capacity (NFCC);
 - (j) Notice of Award of Contract and winning bidder's "Conforme" thereto;
- 3. In consideration of the payments to be made by CIAC to the SUPPLIER as hereinafter mentioned, the SUPPLIER hereby covenants with CIAC to provide the goods and to remedy defects therein in conformity in all respects with the provisions of the Contract.

4. The CIAC hereby covenants to pay the SUPPLIER in consideration of the goods and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
