

**INVITATION TO BID FOR
CONTRACTING THE SERVICES OF FORTY (40)
PRIVATE SECURITY AGENCY (PSA) GUARDS (RE-BID)**

1. The **Clark International Airport Corporation (CIAC)**, through the Corporate Budget for CY 2020, intends to apply the sum of **Seven Million Two Hundred Three Thousand Five Hundred Fifty Eight Pesos & 51/100 (PHP7,203,558.51)** being the Approved Budget for the Contract (ABC) to payments under the contract: Contracting the Services of Forty (40) Private Security Agency (PSA) Guards (Re-bid). Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The CIAC now invites bids for the project: "Contracting the Services of Forty (40) Private Security Agency (PSA) Guards (Re-bid)." The contract duration is Five (5) months and Sixteen (16) days from receipt of the Notice to Proceed. Bidders should have completed within five (5) years, from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from CIAC the Bids and Awards Committee (BAC) Secretariat through the email address given below.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **21 May 2020 until the deadline for the Submission of Bids** upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Ten Thousand Pesos (PHP10,000.00). Bidders are required to coordinate with the BAC Secretariat Office through the email address provided below for the procedure on the payment of the bidding documents' fee.
6. The CIAC-BAC will hold a Pre-Bid Conference on **29 May 2020 (Friday), 2:00 p.m.** which shall be open to prospective bidders. In order to comply with the directive to adopt social/physical distancing measures, the CIAC-BAC shall conduct the Pre-bid Conference thru video conferencing or teleconferencing pursuant to Section 22.3 of the Revised IRR of RA No. 9184. Prospective bidders who are interested to participate in the Pre-bid Conference shall inform the CIAC-BAC and coordinate with the BAC Secretariat through the email address provided below.

All correspondence to and from the CIAC-BAC shall be coursed through the email address provided below. The deadline for the submission of queries and/or requests for clarification shall be on **1 June 2020 not later than 5:00 p.m.**

7. Bids must be delivered **on or before 10 June 2020 (Wednesday), 10:00 a.m. at the Records Management Office (RMO), Corporate Office Building, Civil Aviation Complex, Clark Freeport Zone.** All bids must be accompanied by a Bid Security in any acceptable forms and in amount stated in ITB Clause 18.

Bid opening shall be on **10 June 2020 (Wednesday), 10:15 a.m. at the CIAC Board Room, Corporate Office Building, Civil Aviation Complex, Clark Freeport Zone.** Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The CIAC reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
