

**CONTRACT AGREEMENT FOR THE SUPPLY AND INSTALLATION
OF LED APRON FLOODLIGHTS AND OBSTRUCTION LIGHTS AT
THE APRON RAMP AND REMOTE PARKING AREA OF CIAC**

THIS AGREEMENT made this 22nd day of May 2017 between **CLARK INTERNATIONAL AIRPORT CORPORATION** of Corporate Office Building, Civil Aviation Complex, Clark Freeport Zone, Philippines (hereinafter called "**CIAC**") of the one part and **ECOSHIFT CORPORATION** of 11th Floor Cyberzone Building, Eastwood Cyberpark City, Bagumbayan, Quezon City (hereinafter called the "**SUPPLIER**") of the other part:

WHEREAS the CIAC invited Bids for certain goods and ancillary services, viz., **SUPPLY AND INSTALLATION OF LED APRON FLOODLIGHTS AND OBSTRUCTION LIGHTS AT THE APRON RAMP AND REMOTE PARKING AREA OF CIAC** and has accepted a Bid by the SUPPLIER for the supply of those goods in the sum of **TWENTY FOUR MILLION NINE HUNDRED NINETY NINE THOUSAND NINE HUNDRED NINETY SEVEN PESOS AND 00/100 (PHP24,999,997.00)** (hereinafter called the "**Contract Price**").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - (a) General and Special Conditions of the Contract ;
 - (b) Technical Specifications;
 - (c) Invitation to Bid;
 - (d) Bidding Documents (**ANNEX A**);
 - (e) Supplemental Bid Bulletin;
 - (f) Bid form including all the documents/statements contained in the winning bidder's bidding envelopes (**ANNEX B**);
 - (g) Eligibility requirements, documents and/or statements (**ANNEX C**);
 - (h) Performance Bond;
 - (i) Net Financial Contracting Capacity (NFCC);
 - (j) Notice of Award of Contract and winning bidder's "Conforme" thereto;
3. In consideration of the payments to be made by CIAC to the SUPPLIER as hereinafter mentioned, the SUPPLIER hereby covenants with CIAC to provide the goods and to remedy defects therein in conformity in all respects with the provisions of the Contract.

4. The CIAC hereby covenants to pay the SUPPLIER in consideration of the goods and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.




