



## INVITATION TO BID

### CONSTRUCTION OF THE HORIZONTAL INFRASTRUCTURE PROJECT OF THE CLARK INTERNATIONAL AIRPORT NEW TERMINAL BUILDING PROJECT (FORMERLY CLARK AIRPORT LOW COST TERMINAL)

1. The Clark International Airport Corporation (CIAC), through the funds from the Government of the Philippines (GOP) through the 2016 General Appropriations Act for the Department of Transportation (DOTr) intends to apply the sum of **Two Billion Four Hundred Eighty Five Million Eight Hundred Eleven Thousand Two Hundred Forty Two Pesos and 94/100 (PHP2,485,811,242.94)** inclusive of all applicable taxes and fees, being the Approved Budget for the Contract (ABC), for the **Construction of the Horizontal Infrastructure Project of the Clark International Airport New Terminal Building Project (Formerly Clark Airport Low Cost Terminal)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. CIAC now invites bids for the **Construction of the Horizontal Infrastructure Project of the Clark International Airport New Terminal Building Project (Formerly Clark Airport Low Cost Terminal) located at Clark Freeport Zone, Pampanga. Completion of work is required in Three Hundred Ninety (390) calendar days from receipt of the Notice to Proceed (NTP)**. Bidders must have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using the non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Bidders must have at least a license category "AAA" and a license classification "Large B" from the Philippine Contractors Accreditation Board (PCAB) for **General Engineering: GE-1**. The PCAB license must be valid and effective at the time of submission of the bid.
5. Interested bidders may obtain further information from CIAC and inspect the Bidding Documents at the address given below from Monday to Friday during office hours between 8:00 AM and 5:00 PM.
6. A complete set of Bidding Documents may be acquired by interested bidders from **18 July 2018 until 10:00 AM of 10 August 2018**, from the address below and upon payment of a non-refundable applicable fee for the Bidding Documents, pursuant to the latest guidelines issued by the GPPB, in the amount of **Seventy Five Thousand Pesos (PHP75,000.00)**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System ([www.philgeps.gov.ph](http://www.philgeps.gov.ph)) and website of the CIAC ([www.clarkairport.com](http://www.clarkairport.com)), provided that bidders shall pay the non-refundable fee for the Bidding Documents not later than the submission of their bids.



7. The CIAC-SBAC will hold a Pre-Bid Conference **on 26 July 2018 (Thursday), 10:00 AM at the CIAC Board Room, Corporate Office Building, Civil Aviation Complex, Clark Freeport Zone**, which shall be open to prospective bidders.
8. Bids must be delivered **on or before 10:00 AM of 10 August 2018 (Friday) at the Records Management Office, CIAC Corporate Office Building, Civil Aviation Complex, Clark Freeport Zone, Pampanga**. All bids must be accompanied by a bid security in any of the acceptable forms stated in ITB Clause 18. Late bids shall not be accepted.  
  
Bids will be opened in the presence of the bidders' representatives on **10 August 2018 (Friday), 10:15 AM at the CIAC Board Room, Corporate Office Building, Civil Aviation Complex, Clark Freeport Zone, Pampanga**.
9. CIAC reserves the right to accept or reject any bid, to terminate the bidding process, and to reject all bids at any time prior to contract award, without incurring any liability to the affected bidder or bidders.
