At the onset, the Chairman mentioned the purpose of the meeting that is to give opportunity to prospective bidders to seek clarifications, should they have, regarding the tender process and the bidding documents.

After Chairman Melo inquired whether the prospective bidder have read the contents of the bidding documents, they proceeded with the clarifications of the project.

		Mark Martinez of UICI narrated: as shown here the scope of the project, the target areas is the propose new apron and propose taxiways, demolition of the affected taxiways, old runway. Next is the construction of new taxiways A, F1,F2, and F3.
		Taxiways F1,F2, and F3 actually exists right now, but we propose in our design that it be reconstructed and then the conversion of the old runway to taxiway. We actually have an existing runway which is currently decommissioned. To facilitate the New Terminal Building we are planning to revive it as a taxiway.
		And then of course the construction of the taxiway shoulders, we specify this as a separate item, which is exactly just right on the side of the main pavement of the taxiway.

Clarification from Lito Hukom of DMCI.

I think I saw advance payment per Fifteen percent (15 %), we are using IRR 9184 or the Procurement Law, there is a conflict in there CM Pancho representative is right, in the Special Condition of Contract (SCC) it refers to the mobilization fee, while on their hand on the General Condition of Contract (GCC) it allows Fifteen percent (15 %), standard procurement law a policy on the advance payment, so there is a conflict. Or there is no conflict because that is mobilization, this is advance payment, so I do not know, but it is in your document that advance payment is allowed, now there is a Department Order (D.O.) by DOTr, we are asking if the Department Order is part of the procurement law to be use for this govern, project? will Which procurement law you are using or the D.O. of DOTr?

The procurement law is the more general law , now we are also under the DOTr so it is a more particular order which pretains to mobilization fees and advance payments. parang mas particular po yun, we are more constrain with regards to the DOTr order. Of course the 9184 states otherwise but meron pa ho kaming mas particular rule. which is the DOTr law which prohibits our project not to provide advance payment or mobilization fee, sana vou would understand, if it were not a DOTr project then we would not be bound by this, but this is a DOTr parcel project, we are just the implementor, we have to abide by their rules.

  - a. Will this project require so much volume of aggregates, in terms of concrete and asphalt base, are you considering providing the contractor for the lay down area for the aggregates and possible the plant for cement batching plant
  - b. What about accommodation for our people? The area where we can construct barracks for the workers

The site inspection will be conducted after the pre-bid conference. A scheduled site inspection can be arranged, however a formal request letter addressed to the Chairman of the SBAC will be required from the contractor.

- 4. Queries from Alfredo Fulgencio of CM Pancho Construction Inc.
  - a. It is specified under the Special Condition of Contract that there is no advance payment for this project, also the mobilization, may we know the mode of payment, for example progress billing, can you explain to us the other mode of payment

For the information of everyone, this is also a DOTr project, so the DOTr does not have advance payment and mobilization fees, so it will be a progress billing.

Per Admin Order of DOTr, advance payment and mobilization fee are not allowed. We will answer you in our SBB.

b. With regard to the SCC under clause 40. 1 it specify here that no further instructions, does it mean that we will use the General Condition of Contract is progress payment, since there is no further instruction?

Yes.

c. Do we have a limitation of working hours during construction period?

No limitation.

d. We can work Twenty Four (24) hours?

Yes.

 e. We noted in the bill of quantities there is drainage, the quantities are 23 hectares, can you provide us more detailed Bill of Quantities? Because the quantities given is 23 hectares, there are many composition under drainage,

In the Supplemental Bid Bulletin that will be issued you will be given a breakdown of what items are included in this particular item. You can check technical specification which is also included in the bid documents.

f. And also kindly provide the for example specification, we noted that some item here would be concrete CCP specify the 7000 psi but for other item of works like in the taxiway, it does not specify strength? In your specs, it is not specified.

Usually for the taxiway and apron itself the main pavement is 7000 PSI. for the equivalent compressive you could also find that it is 7000 PSI, we just translated that to its equivalent structural strength which is 7000 PSI.

There being no other clarification or guery, Chairman Melo read the additional reminders for the information and guidance of the prospective bidders:

- Last day for submission of clarification and queries is on July 31, 2018 (Tuesday) not later than 5:00 pm;
- b. Issuance of supplemental bid bulletin is on August 3, 2018 (Friday);
- c. The deadline for the submission of bids is on August 10, 2018 (Friday) no later than 10:00 am at the CIAC-Records Management office (RMO);
- The opening of bids shall be conducted at 10:15 am of August 10, 2018 (Friday) at the CIAC Board Room, CIAC Corporate Office Building, Clark Civil Aviation Complex. Clark Freeport Zone, Pampanga;
- e. Should a bidder decide not to submit a bid, she/he should justify in writing to the BAC the reason for the non-submission. Sanctions shall be imposed to the bidders who withdraw from the bidding or submit late bids or submit patenty insufficient bids for at least three (3) times within a year, except for a valid reason;
- Bidders are reminded that a suspended or blacklisted supplier, contractor or consultant shall not be allowed to participate in all procurement opportunities of the government for the duration of the suspension or blacklisting, regardless of the modality of procurement employed by the procuring entity.
- Caution to prospective bidders, should there be individuals posing in behalf of the BAC and TWG as agents or fixers, the same should be reported to the BAC immediately. This shall not be tolerated by the BAC. The bidding shall be conducted impartially and fairly and no favoritism shall be extended to any prospective bidder. For as long as the prospective bidders submit complete requirements.

vi) In the case of procurement of infrastructure projects. a valid Philippine Contractors Accreditation Board (PCAB) license or Special PCAB license in case of joint **venture**, and registration for the type and cost of the contract to be bid.

Site inspection shall be conducted at 1:30 pm today, the meeting place shall be beside the airport tower front the lobby of the Corporate Office Building. Engr. Ramoncito D.Payad and Engr.Gil M. Bathan will be the coordinating personnel for the site inspection.
