## **SUPPLEMENTAL\BID BULLETIN NO.1**

This Supplemental/Bid Bulletin is issued to modify, amend or clarify items in the Bidding Documents of the Clark International Airport Corporation (CIAC) for the project: Supply and Delivery of IT Equipment and Software. This shall form an integral part of the bidding documents for the above-mentioned project.

I. Below are the queries raised by the prospective bidders during the Pre-Bid Conference held on February 5, 2018 at the CIAC Board Room, as well as the corresponding remarks or instructions made by the Bids and Awards Committee (BAC) members.

Item	Queries\Clarifications	Remarks/Instructions
1.	Query from Kim David of PLDT:  With regard to One (1) lot Blade Server chassis, may we know if the Blade chassis is Ten (10) rack units?	No. Six (6) rack units only. Height: 10.5", Width: 17.5, Depth:32"
2.	Query from Kim David of PLDT:  With regard to the number of Blade Server node, may we know how many Blade Server nodes will be required for this project?	The chassis is composed of Eight (8) Blade servers, there are half-sized, two processors composed of 2.1 Ghz, 128 GB RAM, 2x 1.2TB HDD SAS for each server, sub chassis with eight (8) servers inside.
3.	Query from Kim David of PLDT:  May we know if the One (1) chassis is required to be filled with eight (8) blade servers?	Yes. With full accessories.
4.	Query from Kim David of PLDT:  May we know how many fiber interconnect will it require?	Fiber interconnect would require one (1) fiber interconnect. 8x 8 Gbps Fiber Channel SW SFP+LC
5.	Query from Kim David of PLDT:  With regard to One (1) lot Blade Server chassis, may we know the existing infrastructure CIAC is currently using?	Existing storage must be compatible or can be attached to the Blade Server.

II. The following are the requests and queries submitted by Kim David of PLDT in its letter dated 6 February 2018 and the corresponding remarks and/or instructions made by BAC members and end-user:

Technical Specification under Page 83 "PERC Integrated RAID Controller"	Servers that has a RAID Controller that supports RAID 0,1, 5, 6 and 10.

- III. Additional reminders and clarifications to all prospective proponents:
  - The bidding process involves non-discretionary pass/fail criteria, whereby, if a Bidder submits the required document, it shall be rated as "passed" for that particular requirement. In this regard, Bids that fail to include any requirement or are incomplete or patently insufficient shall be considered or rated as "failed";
  - 2. The original and copies of the bids shall be typed or written in indelible ink and shall be signed on each and every page by the bidder or its duly authorized representative/s;
  - 3. The deadline for the Submission of Bids is on February 19, 2018 (Monday) no later than 2:30 PM Philippine Standard Time (PST) at the Records Management Office (RMO) CIAC Corporate Office Building, Clark Civil Aviation Complex, Clark Freeport Zone, Pampanga. Late bids shall not be accepted;
  - The Opening of Bids shall be conducted on the same day at 2:45 PM, CIAC Board Room, Corporate Office Building, Clark Freeport Zone, Pampanga;
  - 5. No additional documents shall be accepted by the BAC after the deadline for the Submission of Bids;
  - Prospective bidders are reminded that CIAC is VAT exempt. Thus, the bid offer or financial proposal shall be exclusive of VAT;
  - 7. Bidders are required to make use and submit the revised Omnibus Sworn Statement form.

CIAC reserves the right to accept or reject any bids to annul the bidding process and to reject all bid proposals at any time prior to contract award, without thereby incurring any liability to the affected or bidders.
