> With regard to item number 7, Conference Table, 22-seater (solid wood), may we know the thickness of the Conference table?




The thickness shall be 1 1/2" Top Table, The Aluminum Leg Frame shall be amended to Solid Wood.

- 4. The Opening of Bids shall be conducted on the same day at 9:45 AM, CIAC Board Room, Corporate Office Building, Clark Freeport Zone, Pampanga;
- 5. No additional documents shall be accepted by the BAC after the deadline for the Submission of Bids;
- 6. Prospective bidders are reminded that CIAC is VAT-exempt. Thus, the bid offer or financial proposal shall be exclusive of VAT;
- 7. Bidders are required to make use and submit the revised Omnibus Sworn Statement form.
