1.	Query from Carryboy Philppines  With regard to the type of Ambulance, what type of ambulance do we need to deliver?	Type III, with standard compartment measurement as stated in the specification.
2.	Clarification from Carryboy Philippines.  With regard to the warranties, may we have some clarification on such items such as accessories.	The warranty shall be a minimum of two (2) years for the chassis and compartment. The warranties of Medical apparatus and equipment will depend on the manufacturer of the item.
3.	Query from Carryboy Philppines  With regard to the measurement of specifications stated in the bid documents, may we request for a copy?	Yes, CIAC will provide a copy to the bidders who have purchased the Bid Documents.
4.	Query from Promatech  With regard to the number of wheels on the type III ambulance, what will be the specification for this item?	Two (2) front wheels Four (4) rear wheels with one (1) axle
5.	Query from Carryboy Philppines  With regard to the specification of the engine for the type III ambulance, may we know the specification for this item?	Preferably V-eight (8) cylinder turbo diesel engine.
6.	Query from Promatech  With regard to the Insurance coverage for the Type III ambulance, may we know if this is included in the contract?	Yes, the bidder will have to coordinate with the Government Social Insurance Service (GSIS) to determine the cost of the Insurance premium for the Type III Ambulance.

  - 5. No additional documents shall be accepted by the BAC after the deadline for the Submission of Bids.
  - 6. Only those who have <u>Letter of Authorization</u> from their companies stating that they are the authorized representative shall be allowed to participate. The letter of authorization shall be submitted upon submission of their bids.
