SUPPLEMENTAL/BID BULLETIN NO.1

This Supplemental/Bid Bulletin is issued to modify, amend or clarify items in the bidding documents for the Supply and Delivery of One (1) Unit Boom Truck for Clark International Airport Corporation. This shall form an integral part of the bidding documents issued for the above-mentioned project.

I. The following were the queries raised by the prospective bidders during the Pre-Bid Conference, and the corresponding remarks or instructions made by Bids and Awards Committee members and Office of Primary Responsibility (OPR):

Item	Queries	Remarks/Instructions
1.	Clarification from Project Management With regard to the Security Bond, may we know if we could post a Bid Securing Declaration or Bid Security?	Bidders may submit either of the two (2): (a) Bid Securing Declaration or (b) Bid Security. However, please be aware of the consequences in submitting a Bid Securing Declaration.
2.	Request from Tri-globe Inc. With regard to the delivery date of the Boom Truck, may we request for an extension on the delivery date of forty five (45) calendar days?	CIAC shall grant the extension on the delivery date of forty five (45) calendar days.
3.	Clarification from Project Management With regard to the Gross Vehicle Weight (GVW), may we know the specification for this item?	The minimum Gross Vehicle Weight (GVW) of the Truck shall be eight thousand (8,000 Kg) kilograms.
4.	Clarification from Project Management With regard to the length of the Boom Truck, may we have some clarification with regard to the specific length of the Boom truck?	The overall length of the boom truck shall be equal or greater than seven thousand (7,000mm) millimeters, while the overall width shall be equal or greater than two thousand (2,000 mm) millimeter.
5.	Query from Tri-globe Inc. With regard to the manufacturer's warranty of the Boom Truck, may we know if we would need a certification	As long as the bidder is the duly authorized dealer of the manufacturer for the Boom Truck, the said bidder shall provide the

	from the manufacturer?	warranty.
6.	Query from Project Management	
	With regard to the specification of the Boom Truck, will CIAC consider another type of boom such as knuckle type?	As specified in Section VII Technical Specification, boom type shall be of telescopic. CIAC will not consider other types of boom such as the knuckle type.
7.	Query from Project Management	
	With regard to the specification on the working height and side reach of the Boom Truck, may we know the maximum working height and side reach?	The maximum working height of the boom shall be equal or greater than sixteen point seven (16.7) meters (to the bucket top) and the maximum working side reach shall be equal or greater than nine (9) meters.
8.	Query from Tri-globe Inc	
	With regard to the taxes and charges, may we know if CIAC is tax exempt?	Bidders will have to shoulder all charges for this project; CIAC shall provide all necessary documents for the bidder to avail the exemption on duties and taxes for this particular project.
9.	Query from Project Management	
	With regard to the platform of the Boom Truck, may we know if we could use stainless steel instead of fiberglass?	As specified in Section VII Technical Specification, the material type of the boom platform is fiberglass reinforced plastic and CIAC will not consider other type of materials for the boom platform.

II. Additional reminders and clarifications to all prospective bidders:

- 1. The bidding process involves non-discretionary pass/fail criteria, whereby, if a Bidder submits the required document, it shall be rated "pass" for that particular requirement. In this regard. Bids that fail to include any requirement or are incomplete or patently insufficient shall be considered or rated "fail".
- 2. The original and copies of the bids shall be typed or written in indelible ink and shall be signed on each pages by the bidder or its duly authorized representative/s.
- 3. The deadline for the Submission of Bids is on November 13, 2014 (Thursday) not later than 3:00 PM Philippine Standard Time (PST) at the Records Management Office (RMO) CIAC Corporate Office Building, Clark Civil Aviation Complex, Clark Freeport Zone, Pampanga. Late bids shall not be accepted.

4. The Opening of Bids shall be conducted on the same day, at 3:15 PM, CIAC Board Room, Corporate Office Building, Clark Freeport Zone, Pampanga.

- 5. No additional documents shall be accepted by the BAC after the deadline for the Submission of Bids.
- 6. Only those who have <u>Letter of Authorization</u> from their companies stating that they are the authorized representative shall be allowed to participate. The letter of authorization shall be submitted upon submission of their bids.
- 7. Prospective bidders are reminded that CIAC is VAT exempt. Thus, the bid offer or financial proposal shall be exclusive of VAT.
- 8. Bidders are required to make use and submit the revised Omnibus Sworn Statement form

CIAC reserves the right to accept or reject any bids to annul the bidding process and to reject all bid proposals at any time prior to contract award, without thereby incurring any liability to the affected or bidders.
