



## SUPPLEMENTAL/BID BULLETIN NO.1

This Supplemental/Bid Bulletin is issued to modify, amend or clarify items in the bidding documents for the Supply and Delivery of Eleven (11) Units Brand New Service Vehicles for Clark International Airport Corporation. This shall form an integral part of the bidding documents issued for the above-mentioned project.

- I. The following were the queries raised by the prospective bidders during the Pre-Bid Conference, and the corresponding remarks or instructions made by Bids and Awards Committee members and Office of Primary Responsibility (OPR):

Item	Queries	Remarks/Instructions
1.	Query from Toyota San Fernando  With regard to the color of the vehicle units, will CIAC allow us to deliver a common color for the vehicles units?	Yes, for the one (1) unit mint green pick-up (Command vehicle) only. White color is acceptable.
2.	Query from Toyota San Fernando  With regard to the insurance coverage of the eleven (11) vehicles, will this be included in the contract bid?	Yes, insurance coverage for the eleven (11) vehicles should be included in the contract bid.
3.	Query from Toyota San Fernando  With regard to the license plate, will this be red plates or green plates?	License plates for the eleven (11) vehicles should be red plates.
4.	Query from Toyota San Fernando  With regard to the ongoing project, may we use invoices instead of official receipt?	Yes, delivery receipt/s or invoice/s shall be accepted in lieu of the official receipt/s for ongoing project. For completed projects, bidders may submit official receipt/s.
5.	Query from Ford San Fernando  With regard to the brand of vehicles, may we also offer multi-brand for this bid?	Yes, any brand can do as long the brand that you will offer will meet the minimum requirement under Section VII of the Technical Specification of the bidding documents.
6.	Query from Ford San Fernando  With regard to the new form for the	Yes, the new Omnibus Sworn Statement form is

II. Additional reminders and clarifications to all prospective bidders:


1. The bidding process involves non-discretionary pass/fail criteria, whereby, if a Bidder submits the required document, it shall be rated "pass" for that particular requirement. In this regard, Bids that fail to include any requirement or are incomplete or patently insufficient shall be considered or rated "fail".
2. The original and copies of the bids shall be typed or written in indelible ink and shall be signed on each pages by the bidder or its duly authorized representative/s.
3. The deadline for the Submission of Bids is on November 13, 2014 (Thursday) not later than 10:00 AM Philippine Standard Time (PST) at the Records Management Office (RMO) CIAC Corporate Office Building, Clark Civil Aviation Complex, Clark Freeport Zone, Pampanga. Late bids shall not be accepted.
4. The Opening of Bids shall be conducted on the same day, at 10:15 PM, CIAC Board Room, Corporate Office Building, Clark Freeport Zone, Pampanga.
5. No additional documents shall be accepted by the BAC after the deadline for the Submission of Bids.
6. Only those who have Letter of Authorization from their companies stating that they are the authorized representative shall be allowed to participate. The letter of authorization shall be submitted upon submission of their bids.
7. Prospective bidders are reminded that CIAC is VAT exempt. Thus, the bid offer or financial proposal shall be exclusive of VAT.
8. Bidders are required to make use and submit the revised Omnibus Sworn Statement form.

CIAC reserves the right to accept or reject any bids to annul the bidding process and to reject all bid proposals at any time prior to contract award, without thereby incurring any liability to the affected or bidders.
