This Supplemental/Bid Bulletin is issued to modify, amend or clarify items in the bidding documents for the Supply and Delivery of One (1) Unit Runway Vacuum Sweeper Truck for Clark International Airport Corporation this shall form an integral part of the bidding documents issued for the above-mentioned project.

- I. The following were the queries raised by the prospective bidders during the Pre-Bid Conference, and the corresponding remarks or instructions made by Bids and Awards Committee members and Office of Primary Responsibility (OPR):




1.	<p>Clarification from Cliamco Industrial Corp.</p> <p>With regard to technical specification under scope of services on page 69 on the Bid Documents, its states that the taxes shall be shouldered by the supplier, we understand that CIAC is Tax exempt; may we ask for some clarification on this matter?</p>	<p>All importation of goods to Clark Freeport Zone shall be Tax and Duty free. CIAC will assist the bidder in the documentation of the Tax exemption of the equipment to be use within the Clark Freeport Zone.</p>

II. Additional reminders and clarifications to all prospective bidders:

- The bidding process involves non-discretionary pass/fail criteria, whereby, if a Bidder submits the required document, it shall be rated "pass" for that particular requirement. In this regard, Bids that fail to include any requirement or are incomplete or patently insufficient shall be considered or rated "fail".
- The original and copies of the bids shall be typed or written in indelible ink and shall be signed on each pages by the bidder or its duly authorized representative/s.
- The deadline for the Submission of Bids is on November 20, 2014 (Thursday) not later than 3:00 PM Philippine Standard Time (PST) at the Records Management Office (RMO) CIAC Corporate Office Building, Clark Civil Aviation Complex, Clark Freeport Zone, Pampanga. Late bids shall not be accepted.
- The Opening of Bids shall be conducted on the same day, at 3:15 PM, CIAC Board Room, Corporate Office Building, Clark Freeport Zone, Pampanga.
- No additional documents shall be accepted by the BAC after the deadline for the Submission of Bids.
- Only those who have Letter of Authorization from their companies stating that they are the authorized representative shall be allowed to participate. The letter of authorization shall be submitted upon submission of their bids.
- Prospective bidders are reminded that CIAC is VAT exempt. Thus, the bid offer or financial proposal shall be exclusive of VAT.
- Bidders are required to make use and submit the revised Omnibus Sworn Statement form.

CIAC reserves the right to accept or reject any bids to annul the bidding process and to reject all bid proposals at any time prior to contract award, without thereby incurring any liability to the affected or bidders.
