




SUPPLEMENTAL/BID BULLETIN NO. 2


This Supplemental/Bid Bulletin is issued to modify, amend or clarify items in the bidding documents for the Supply and Delivery of Two (2) Units Tractor with Four (4) Units Implements for Clark International Airport Corporation this shall form an integral part of the bidding documents issued for the above-mentioned project.

- I. The following were the queries raised by the prospective bidders during the Pre-Bid Conference, and the corresponding remarks or instructions made by Bids and Awards Committee members and Office of Primary Responsibility (OPR):

Item	Queries	Remarks\Instruction
1.	Query from Project Management/ Technical Resources With regard to the Approved Budget of this Contract (ABC), may we know if this is exclusive of Tax	CIAC operate inside the Clark Freeport Zone; which is a tax free zone. thus, is exclusive of Tax.
2.	Query from Project Management/ Technical Resources With regard to the delivery date schedule, may we know if we can ask for an extension of the delivery date?	CIAC shall extend the delivery period from fifteen (15) working days to sixty (60) working days.
3.	Clarification from Project Management/ Technical Resources Corporation With regard to the specification, may we ask for some clarification in the type of diesel injection pump and specification of the RPM of the engine?	The type of diesel injection pump must be direct injection, in-line or rotary, and the specified rpm shall be equal or more than 2000 rpm.
4.	Request from Go Tracktora Trading With regard to the length of the roto slasher implements, may	The cutting width of the roto slasher must be equal or greater than 175 inches, while the



	we request in the reduction in the specification?	minimum cutting height must be two (2) inches.
5.	Request from John Deer With regard to the Front End Loader of the Tractor, may we offer a different attachment such as a backhoe?	As specified in Section VII of the bidding documents, one of the attachments must be a front-end loader; therefore CIAC will not accept backhoe as an alternative implement/attachment.
6.	Query from Project Management/ Technical Resources With regard to the additional accessories for the tractor such as ballast weight, may we know how many kilos (kgs) will be needed? Will this be attached on the frontend or attached on the wheels?	The Supplier must deliver the ballast weight compatible to their tractor to be attached on both rear and front of the tractor.
7.	Query from Project Management/ Technical Resources With regard to the Eligibility document, registration certificate from the Security Exchange Commission(SEC), Department of Trade and Industries(DTI), may we know which is applicable	The certification will be whichever is applicable for your company. If your company is a corporation or partnership. you would need to submit a certification from SEC. if it is a sole proprietor, a certification from DTI.
8.	Query from Project Management/ Technical Resources With regard to the Statement of all on-going Private and Government Contracts, may we know what will we put in this item?	Please refer to the Bid Documents to Instruction to Bidders particularly Sec.12.1(a)(iii).
9.	Query from Project Management/ Technical Resources With regard to the mode of payments, may we know the	Please refer to clause 10 & 11 of General Conditions of Contract (GCC)

10.	Query from Project Management/ Technical Resources With regard to the opening of a Letter of Credit (LC), will CIAC be opening a letter of credit for this project?	No.

II. The following are request and query submitted by Project Management & Technical Resources Corporation and corresponding remarks and/ or instruction made by BAC members and Office of the Primary Responsibility (OPR)

Item	Queries	Remarks\Instructions
1.	With regard to the Delivery Schedule of fifteen (15) working days, may we request for an extension?	Yes, Please refer to item No 2 for instructions
2.	With regard to our request to offer the 67HP DIN (77hp) of our tiger 70, 4wd 3 cylinders turbocharged, 2350 RPM, Direct Injection, may we offer this specification?	Yes, as long as it meets the minimum horsepower requirement as stated in the TOR.
3.	With regard to the tractor wheels and dimensions, may we offer to use our tractor manufacture standard specification?	Tractor Tire size shall be equal or greater than 11.2 x 24pr at front and 16.9 x 30 at rear.
4.	With regard to the specification of the Roto Slasher, may we offer a cutting width of 3' (177'only) while the cutting height ranges from 1' to 4'.	Yes, Please refer to item no.4 for instructions
5.	With regard to the one (1) unit Rotovator, I think the phrase "the number of discs" should be number of blades.	Yes, the phrase for Rotovator should be discs or blades.


III. Additional reminders and clarifications to all prospective bidders:

1. The bidding process involves non-discretionary pass/fail criteria, whereby, if a Bidder submits the required document, it shall be rated "pass" for that particular requirement. In this regard, Bids that fail to include any requirement or are incomplete or patently insufficient shall be considered or rated "fail".
2. The original and copies of the bids shall be typed or written in indelible ink and shall be signed on each pages by the bidder or its duly authorized representative/s.

3. The deadline for the Submission of Bids is on November 20, 2014 (Thursday) not later than 2:00 PM Philippine Standard Time (PST) at the Records Management Office (RMO) CIAC Corporate Office Building, Clark Civil Aviation Complex, Clark Freeport Zone, Pampanga. Late bids shall not be accepted.
4. The Opening of Bids shall be conducted on the same day, at 2:15 PM, CIAC Board Room, Corporate Office Building, Clark Freeport Zone, Pampanga.
5. No additional documents shall be accepted by the BAC after the deadline for the Submission of Bids.
6. Only those who have Letter of Authorization from their companies stating that they are the authorized representative shall be allowed to participate. The letter of authorization shall be submitted upon submission of their bids.
7. Prospective bidders are reminded that CIAC is VAT exempt. Thus, the bid offer or financial proposal shall be exclusive of VAT.
8. Bidders are required to make use and submit the revised Omnibus Sworn Statement form.

CIAC reserves the right to accept or reject any bids to annul the bidding process and to reject all bid proposals at any time prior to contract award, without thereby incurring any liability to the affected or bidders.
