## CONTRACT AGREEMENT FOR THE CONTRACTING THE SERVICES OF ONE HUNDRED TWENTY THREE (123) PRIVATE AVIATION SECURITY AGENCY GUARDS (LOT 1)

THIS AGREEMENT made this 23<sup>rd</sup> day of December 2016 between **CLARK INTERNATIONAL AIRPORT CORPORATION** of Corporate Office Building, Civil Aviation Complex, Clark Freeport Zone, Philippines (hereinafter called "**CIAC**") of the one part and **ICT SECURITY AND INVESTIGATION AGENCY, INC.** of Bldg. A, No. 10 President Avenue, BF Homes, Parañaque City (hereinafter called the "**SERVICE PROVIDER**") of the other part:

WHEREAS the CIAC invited Bids for execution and completion of services consisting of: CONTRACTING THE SERVICES OF ONE HUNDRED TWENTY THREE (123) PRIVATE AVIATION SECURITY AGENCY GUARDS (LOT 1) and has accepted a Bid by the SERVICE PROVIDER in the sum of TWENTY EIGHT MILLION NINE HUNDRED EIGHTY TWO THOUSAND FOUR HUNDRED EIGHTY FIVE PESOS AND 08/100 (PHP28,982,485.08) (hereinafter called the "CONTRACT PRICE").

## NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- 2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
  - (a) General and Special Conditions of the Contract;
  - (b) Technical Specifications;
  - (c) Invitation to Bid;
  - (d) Bidding Documents (ANNEX A);
  - (e) Supplemental Bid Bulletin;
  - (f) Bid form including all the documents/statements contained in the winning bidder's bidding envelopes (ANNEX B);
  - (g) Eligibility requirements, documents and/or statements (ANNEX C);
  - (h) Performance Bond:
  - (i) Net Financial Contracting Capacity (NFCC);
  - (j) Notice of Award of Contract and winning bidder's "Conforme" thereto;
- 3. In consideration of the payments to be made by CIAC to the SERVICE PROVIDER as hereinafter mentioned, the SERVICE PROVIDER hereby covenants with CIAC to provide for the execution and completion of services and to remedy defects therein in conformity in all respects with the provisions of the Contract.

4. The CIAC hereby covenants to pay the SERVICE PROVIDER in consideration of the provision of services and the remedying of defects therein, the CONTRACT PRICE or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
