## **INVITATION TO BID**

## SUPPLY, DELIVERY, INSTALLATION AND COMMISSIONING OF ONE (1) UNIT TSA QUALIFIED DUAL VIEW HAND CARRY BAGGAGE X-RAY **MACHINE**

- 1. The Clark International Airport Corporation (CIAC), through the Corporate Budget for CY 2017, intends to apply the sum of SEVEN MILLION FIVE HUNDRED THOUSAND PESOS (PHP7,500,000.00) VAT EXCLUSIVE being the Approved Budget for the Contract (ABC) to payments under the contract for the project: "Supply, Delivery, Installation and Commissioning of One (1) Unit TSA Qualified Dual View Hand Carry Baggage X-ray Machine." Bids received in excess of the ABC shall be automatically rejected at Bid opening.
- The CIAC now invites bids from eligible bidders for the project: "Supply, Delivery, 2. Installation and Commissioning of One (1) Unit TSA Qualified Dual View Hand Carry Baggage X-ray Machine." The project shall be completed within One Hundred Twenty (120) calendar days from receipt of Notice to Proceed. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the project, equivalent to or at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders (ITB).
- 3. Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
  - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, corporations or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
- 4. Interested bidders may obtain further information from CIAC Bids and Awards Committee (BAC) and inspect the Bidding Documents at the address given below from November 3, 2017 until the deadline for the Submission of Bids at 8:00 a.m. to 5:00 p.m.
- A complete set of Bidding Documents may be acquired by interested bidders on November 3, 2017 until the deadline for the Submission of Bids, from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Ten Thousand Pesos (PHP10,000.00).

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (<u>www.philgeps.gov.ph</u>) and website of the CIAC (<u>www.clarkairport.com</u>), provided that bidders shall pay the non-refundable fee for the Bidding Documents not later than the submission of their bids.

- The CIAC-BAC will hold a Pre-Bid Conference on November 16, 2017 (Thursday),
   2:00 p.m. at the CIAC Board Room, Corporate Office Building, Civil Aviation
   Complex, Clark Freeport Zone, Philippines 2023, which shall be open to prospective bidders.
- 7. Bids must be received by the Records Management Office at the CIAC Corporate Office Building, Civil Aviation Complex, Clark Freeport Zone, Philippines 2023 on or before 9:00 a.m. of November 28, 2017 (Tuesday). All bids must be accompanied by a Bid Security in any acceptable forms and in amount stated in ITB Clause 18.
- 8. Bid opening shall be on November 28, 2017 (Tuesday), 9:15 a.m. at the CIAC Board Room, Corporate Office Building, Civil Aviation Complex, Clark Freeport Zone, Philippines 2023. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
- 9. The CIAC reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
