




**Invitation to Bid for the  
SUPPLY, INSTALLATION, TESTING AND COMMISSIONING OF ONE (1) UNIT 40  
kVA UNINTERRUPTIBLE POWER SUPPLY (UPS) AT THE PASSENGER TERMINAL  
BUILDING CHECK-IN AREA**

1. The **Clark International Airport Corporation**, through the Corporate Budget for CY 2017, intends to apply the sum of **One Million Five Hundred Thousand Pesos (PHP 1,500,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the project **"Supply, Installation, Testing and Commissioning of One (1) Unit 40 kVA Uninterruptible Power Supply (UPS) at the Passenger Terminal Building Check-in Area."** Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **Clark International Airport Corporation** now invites bids for the **Supply, Installation, Testing and Commissioning of One (1) Unit 40 kVA Uninterruptible Power Supply (UPS) at Passenger Terminal Building Check-in Area**. Delivery of the Goods is required within ninety (90) calendar days. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from Clark International Airport Corporation BAC Secretariat Office and inspect the Bidding Documents at the address given below during office hours, 8:00 a.m. to 5:00 p.m.
5. A complete set of Bidding Documents may be acquired by interested Bidders from **13 March 2017 until the deadline for the Submission of Bids** from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand Pesos (PHP 5,000.00)**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) ([www.philgeps.gov.ph](http://www.philgeps.gov.ph)) and website of the CIAC ([www.clarkairport.com](http://www.clarkairport.com)), provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.



6. The **Clark International Airport Corporation** will hold a Pre-Bid Conference on **21 March 2017 (Tuesday), 2:00 p.m. at the CIAC Board Room, Corporate Office Building, Clark Civil Aviation Complex, Clark Freeport Zone** which shall be open to prospective bidders.
7. Bids must be duly received by the **Records Management Office (RMO), CIAC Corporate Office Building, Clark Civil Aviation Complex, Clark Freeport Zone on or before 3:30 p.m. of 03 April 2017 (Monday)**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.  
  
Bid opening shall be on **03 April 2017 (Monday), 3:45 p.m. at the CIAC Board Room, Corporate Office Building, Clark Civil Aviation Complex, Clark Freeport Zone**. Bids will be opened in the presence of the bidders' representatives who choose to attend. Late bids shall not be accepted.
8. The **Clark International Airport Corporation** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
