INVITATION TO BID FOR THE SUPPLY AND INSTALLATION OF SEVEN (7) DIESEL ENGINE GENERATOR SETS WITH SCADA, POWER/CONTROL CABLES, AUTO-TRANSFER AND BYPASS SWITCHES

- 1. The Clark International Airport Corporation (CIAC), through the General Appropriations Act (GAA) of 2014, intends to apply the sum of THIRTY FOUR MILLION FIVE HUNDRED THOUSAND PESOS (Php 34,500,000.00) VAT Exclusive being the Approved Budget for the Contract (ABC) for payments under the contract "Supply and Installation of Seven (7) Diesel Engine Generator Sets with Scada, Power/Control Cables, Auto-Transfer and Bypass Switches." Bids received in excess of the ABC shall be automatically rejected at Bid opening.
- 2. The CIAC now invites bids from eligible bidders for Supply and Installation of Seven (7) Diesel Engine Generator Sets with Scada, Power/Control Cables, Auto-Transfer and Bypass Switches. The Supply and Installation of Seven (7) Diesel Engine Generator Sets with Scada, Power/Control Cables, Auto-Transfer and Bypass Switches thereof are required within a period of ONE-HUNDRED EIGHTY (180) CALENDAR DAYS from the receipt of the Notice to Proceed (NTP). Bidders should have completed a project, within ten (10) years from the date of submission and receipt of bids, a contract similar to the project, equivalent to or at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders (ITB).
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria as specified in the revised Implementing Rules and Regulations of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act". Bidding is restricted to Filipino citizens/sole proprietorships, organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to Republic Act 5183 (R.A. 5183) and subject to Commonwealth Act 138 (C.A. 138).
- Interested bidders may obtain further information from CIAC Bids and Awards Committee (BAC) Secretariat and inspect the Bidding Documents at the address given below from 8:00 AM to 5:00 PM.

A complete set of Bidding Documents may be acquired by interested bidders from October 23, 2014 until the deadline for the Submission of Bids at the address below and upon payment of a non-refundable fee in the amount of Twenty Five Thousand Pesos (Php 25,000.00). The acceptable forms of payment are the following: Cash, Cashier's Check or Manager's Check payable to CIAC.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (www.philgeps.gov.ph) and website of the CIAC (www.clarkairport.com), provided that bidders shall pay the non-refundable fee for the Bidding Documents not later than the submission of their bids.

 The CIAC-BAC will hold a Pre-Bid Conference on November 5, 2014, 10:30 AM at the Clark International Airport Corporation, ((IAC) Board Room Corporate Office Building, Clark Freeport Zone which shall be open to all interested parties.

- Bids must be delivered to the address below on or before 2:00 PM, November 19, 2014 at the Records Management Office, CIAC Corporate Office Building, Civil Aviation Complex, Clark Freeport Zone, Philippines 2023. All bids must be accompanied by a Bid Security in any acceptable forms and in amount stated in ITB Clause 18.
  - Bid opening shall be on November 19, 2014, 2:15 PM at the CIAC Board Room, Corporate Office Building, Clark Freeport Zone, Philippines 2023. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
- 7. The Clark International Airport Corporation reserves the right to accept or reject any Bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected Bidder or Bidders.
