



**Invitation to Bid for
THE SUPPLY AND DELIVERY OF TWO HUNDRED SEVENTY (270) FOUR-SEATER
GANG CHAIRS FOR CLARK INTERNATIONAL AIRPORT**

1. The **Clark International Airport Corporation (CIAC)**, through the Corporate Budget for CY 2017, intends to apply the sum of **TEN MILLION PESOS (PHP 10,000,000.00) VAT EXCLUSIVE** being the Approved Budget for the Contract (ABC) to payments under the contract "Supply and Delivery of Two Hundred Seventy (270) Four-Seater Gang Chairs for Clark International Airport." Bids received in excess of the ABC shall be automatically rejected at Bid opening.
2. The CIAC now invites Bids from eligible bidders for the Supply and Delivery of Two Hundred Seventy (270) Four-Seater Gang Chairs for Clark International Airport. Schedule of delivery shall be in accordance with Section VI. Schedule of Requirements. Bidders should have completed, within **five (5) years** from the date of submission and receipt of bids, a contract similar to the project, equivalent to or at least twenty five percent (25%) of the ABC pursuant to Section 23.4.1.3, 2016 revised IRR of R.A. 9184. The description of an eligible bidder is contained in Section II of the Bidding Documents, particularly, in Section II. Instructions to Bidders (ITB).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act". Bidding is restricted to Filipino citizens/sole proprietorships, organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to Republic Act 5183 (R.A. 5183) and subject to Commonwealth Act 138 (C.A. 138).
4. Interested bidders may obtain further information from CIAC Bids and Awards Committee (BAC) Secretariat and inspect the Bidding Documents at the address given below from **20 February 2017 until the deadline for the Submission of Bids.**

A complete set of Bidding Documents may be acquired by interested bidders from the address below and upon payment of a non-refundable fee in the amount of **Ten Thousand Pesos (PHP 10,000.00)**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (www.philgeps.gov.ph) and website of the CIAC (www.clarkairport.com), provided that bidders shall pay the non-refundable fee for the Bidding Documents not later than the submission of their bids.

5. The CIAC-BAC will hold a Pre-Bid Conference on **28 February 2017 (Tuesday), 1:00 p.m. at the CIAC Board Room, Corporate Office Building, Clark Civil Aviation Complex, Clark Freeport Zone, Philippines 2023** which shall be open to all interested parties.

- Bids must be delivered on or before **13 March 2017 (Monday), 3:00 p.m. at the Records Management Office (RMO), CIAC Corporate Office Building, Clark Civil Aviation Complex, Clark Freeport Zone, Philippines 2023.** All bids must be accompanied by a Bid Security in any acceptable forms and in amount stated in ITB Clause 18.

Bid opening shall be on **13 March 2017 (Monday), 3:15 p.m. at the CIAC Board Room, Corporate Office Building, Clark Civil Aviation Complex, Clark Freeport Zone, Philippines 2023.** Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

- The CIAC reserves the right to accept or reject any Bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected Bidder or Bidders.
