




**Invitation to Bid for
THE SUPPLY AND DELIVERY OF TWO (2) UNITS BRAND NEW POLICE TYPE
MOTORCYCLES FOR AVIATION SECURITY DEPARTMENT OF CLARK
INTERNATIONAL AIRPORT CORPORATION**

1. The **Clark International Airport Corporation (CIAC)**, through the **General Appropriations Act (GAA) of 2014**, intends to apply the sum of **SEVEN HUNDRED TWENTY FIVE THOUSAND PESOS (Php 725,000.00) VAT EXCLUSIVE** being the Approved Budget for the Contract (ABC) to payments under the contract for the Supply and Delivery of Two (2) Units Brand new Police Type Motorcycles for Aviation Security Department of Clark International Airport Corporation. Bids received in excess of the ABC shall be automatically rejected at Bid opening.
2. The CIAC now invites Bids from eligible bidders for the Supply and Delivery of Two (2) Units Brand new Police Type Motorcycles for Aviation Security Department of Clark International Airport Corporation. Supply and Delivery of Two (2) Units Brand new Police Type Motorcycles thereof is required within a period of **sixty (60) working days** from receipt of Notice to Proceed. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the project, equivalent to or at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in Section II of the Bidding Documents, particularly, in Section II. Instructions to Bidders (ITB).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act". Bidding is restricted to Filipino citizens/sole proprietorships, organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to Republic Act 5183 (R.A. 5183) and subject to Commonwealth Act 138 (C.A. 138).
4. Interested bidders may obtain further information from CIAC Bids and Awards Committee (BAC) Secretariat and inspect the Bidding Documents at the address given below from 8:00 AM to 5:00 PM.

A complete set of Bidding Documents may be acquired by interested bidders from **October 23, 2014 until the deadline for the Submission of Bids** at the address below and upon payment of a non-refundable fee in the amount of **One Thousand Pesos (Php 1,000.00)**. The acceptable forms of payment are the following: Cash, Cashier's Check or Manager's Check payable to CIAC.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (www.philgeps.gov.ph) and website of the CIAC (www.clarkairport.com), provided that bidders shall pay the non-refundable fee for the Bidding Documents not later than the submission of their bids.

5. The CIAC-BAC will hold a Pre-Bid Conference on **October 31, 2014, 9:00 AM** at the CIAC Board Room, Corporate Office Building, Civil-Aviation Complex, Clark Freeport Zone, Philippines 2023 which shall be open to all interested parties.



6. Bids must be delivered to the CIAC Records Management Office, Corporate Office Building, Clark International Airport Corporation, Civil Aviation Complex, Clark Freeport Zone, Pampanga **on or before 9:00 AM, November 13, 2014**. All bids must be accompanied by a Bid Security in any acceptable forms and in amount stated in ITB Clause 18.

Bid opening shall be on **November 13, 2014, 9:15 AM** at the CIAC Board Room, Corporate Office Building, Civil Aviation Complex, Clark Freeport Zone, Philippines 2023. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

7. The Clark International Airport Corporation reserves the right to accept or reject any Bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected Bidder or Bidders.
