Invitation to Bid for THE SUPPLY AND DELIVERY OF EIGHT (8) PERSONAL PROTECTIVE CLOTHING (PPC)-PROXIMITY SUITS FOR FIREFIGHTERS OF CLARK INTERNATIONAL AIRPORT CORPORATION

- 1. The Clark International Airport Corporation (CIAC), through the Corporate Budget for CY 2016, intends to apply the sum of ONE MILLION AND THREE HUNDRED FIFTY THOUSAND PESOS (PHP 1,350,000.00) VAT EXCLUSIVE being the Approved Budget for the Contract (ABC) to payments under the contract for the Supply and Delivery of Eight (8) Personal Protective Clothing (PPC) - Proximity Suits for Firefighters of Clark International Airport Corporation. Bids received in excess of the ABC shall be automatically rejected at Bid opening.
- 2. The CIAC now invites Bids from eligible bidders for the Supply and Delivery of Eight (8) Personal Protective Clothing (PPC) - Proximity Suits which includes Pants, Coat, Helmet. Shroud, Gloves and Aircraft Rescue Firefighting Boots (ARFF Boots). Delivery period of the project Supply and Delivery of Eight (8) Personal Protective Clothing (PPC) - Proximity Suits for Firefighters of Clark International Airport Corporation is required within thirty (30) working days from receipt of Notice to Proceed. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the project. equivalent to or at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in Section II of the Bidding Documents, particularly, in Section II. Instructions to Bidders (ITB).
- 3. Bidding will be conducted through open competitive bidding procedures using nondiscretionary pass/fail criteria as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act". Bidding is restricted to Filipino citizens/sole proprietorships, organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to Republic Act 5183 (R.A. 5183) and subject to Commonwealth Act 138 (C.A. 138).
- 4. Interested bidders may obtain further information from CIAC Bids and Awards Committee (BAC) Secretariat and inspect the Bidding Documents at the address given below from July 8, 2016 until the deadline for the Submission of Bids.

A complete set of Bidding Documents may be acquired by interested bidders from the address below and upon payment of a non-refundable fee in the amount of Five Thousand Pesos (PHP 5,000.00). The acceptable forms of payment shall be Cash, Cashier's Check or Manager's Check payable to CIAC.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (www.philgeps.gov.ph) and website of the CIAC (www.clarkairport.com), provided that bidders shall pay the non-refundable fee for the Bidding Documents not later than the submission of their bids.

- 5. The CIAC-BAC will hold a Pre-Bid Conference on July 18, 2016 (Monday), 10:00 am at the CIAC Board Room, Corporate Office Building, Civil Aviation Complex, Clark Freeport Zone, Philippines 2023 which shall be open to all interested parties.
- 6. Bids must be delivered on or before 10:00 am, August 1, 2016 (Monday) at the Records Management Office (RMO), Corporate Office Building, Civil Aviation Complex, Clark Freeport Zone, Philippines 2023. All bids must be accompanied by a Bid Security in any acceptable forms and in amount stated in ITB Clause 18.

Bid opening shall be on August 1, 2016 (Monday), 10:15 am at the CIAC Board Room, Corporate Office Building, Civil Aviation Complex, Clark Freeport Zone, Philippines 2023. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

- 7. The Clark International Airport Corporation reserves the right to accept or reject any Bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected Bidder or Bidders.
