Bids received in excess of the ABC shall be automatically rejected at Bid opening.
- 2. The CIAC now invites Bids from eligible bidders for the Supply and Delivery of One (1) Unit Runway Vacuum Sweeper Truck for Clark International Airport Corporation. Delivery of the One (1) Unit Runway Vacuum Sweeper Truck thereof is required within a period of Ninety (90) calendar days from receipt of Notice to Proceed. Bidders should have completed, within Five (5) years from the date of submission and receipt of bids, a contract similar to the project, equivalent to or at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders (ITB).
