


**CONTRACT AGREEMENT FOR THE
UPGRADING OF LANDSIDE FACILITIES AT THE
CLARK CIVIL AVIATION COMPLEX**

THIS AGREEMENT made this 12th day of May 2017 between **CLARK INTERNATIONAL AIRPORT CORPORATION** of Corporate Office Building, Civil Aviation Complex, Clark Freeport Zone, Philippines (hereinafter called "**CIAC**") of the one part and **E.M. CUERPO, INC.**, of No.3 E.M. Cuerpo, Inc. Bldg., Metropoli Drive, Metropoli Residenza, Bagumbayan, Quezon City (hereinafter called the "**CONTRACTOR**") of the other part:

WHEREAS the CIAC invited Bids for execution and completion of works consisting of: **UPGRADING OF LANDSIDE FACILITIES AT THE CLARK CIVIL AVIATION COMPLEX** and has accepted a Bid by the CONTRACTOR in the sum of **ONE HUNDRED EIGHT MILLION EIGHT HUNDRED SEVENTY EIGHT THOUSAND EIGHT HUNDRED EIGHTY EIGHT PESOS AND 33/100 (PHP108,878,888.33)** (hereinafter called the "**CONTRACT PRICE**").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 
1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
 2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - (a) General and Special Conditions of the Contract ;
 - (b) Technical Specifications;
 - (c) Invitation to Bid;
 - (d) Bidding Documents (**ANNEX A**);
 - (e) Supplemental Bid Bulletin;
 - (f) Bid form including all the documents/statements contained in the winning bidder's bidding envelopes (**ANNEX B**);
 - (g) Eligibility requirements, documents and/or statements (**ANNEX C**);
 - (h) Performance Bond;
 - (i) Net Financial Contracting Capacity (NFCC);
 - (j) Notice of Award of Contract and winning bidder's "Conforme" thereto;
 - (k) Notarized Affidavit of Site Inspection;
 - (l) Bar Chart, S-Curve & PERT-CPM; and
 - (m) Construction methodology.
 3. In consideration of the payments to be made by CIAC to the CONTRACTOR as hereinafter mentioned, the CONTRACTOR hereby covenants with CIAC to provide for the execution and completion of works and to remedy defects therein in conformity in all respects with the provisions of the Contract.



4. The CIAC hereby covenants to pay the CONTRACTOR in consideration of the provision of works and the remedying of defects therein, the CONTRACT PRICE or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
