

CONTRACT AGREEMENT FOR THE CONTRACTING THE SECURITY SERVICES OF FIFTY EIGHT (58) PRIVATE SECURITY AGENCY GUARDS

THIS AGREEMENT made the 28th day of December 2020 between **CLARK INTERNATIONAL AIRPORT CORPORATION** of Corporate Office Building, Civil Aviation Complex, Clark Freeport Zone, Philippines (hereinafter called the "Entity") of the one part and **888 GALLANT SECURITY SERVICES CORPORATION**, of 558-A Quirino Avenue, Bgy. Tambo, Parañaque City (hereinafter called the "Service Provider") of the other part:

WHEREAS, the Entity invited Bids for execution and completion of services consisting of: **CONTRACTING THE SERVICES OF FIFTY EIGHT (58) PRIVATE SECURITY AGENCY GUARDS** and has accepted a Bid by the Service Provider in the sum of **TWENTY TWO MILLION NINE HUNDRED THIRTY THREE THOUSAND THIRTY NINE PESOS AND 84/100 (PHP22,933,039.84)** (hereinafter called the "Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, *viz.*:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from



the Procuring Entity's bid evaluation;

- iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
3. In consideration for the sum of **TWENTY TWO MILLION NINE HUNDRED THIRTY THREE THOUSAND THIRTY NINE PESOS AND 84/100 (PHP22,933,039.84)** or such other sums as may be ascertained, Petron Corporation agrees to provide the goods and services in accordance with its Bid.
4. The Clark International Airport Corporation agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
