CONTRACT AGREEMENT FOR THE CONTRACTING OF JANITORIAL SERVICES FOR CIAC

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- In consideration for the sum of TWO MILLION FOUR HUNDRED TWENTY SEVEN THOUSAND NINE HUNDRED SIXTY TWO PESOS AND 91/100 (PHP2,427,962.91) or such other sums as may be ascertained, Omniworx, Inc. agrees to provide the goods and services in accordance with its Bid.
- 4. The Clark International Airport Corporation agrees to pay the abovementioned sum in accordance with the terms of the Bidding.
