

CONTRACT AGREEMENT FOR THE CONTRACTING OF JANITORIAL SERVICES FOR CIAC CY 2023

This Agreement, made this ____ day of _____ 2023 between:

CLARK INTERNATIONAL AIRPORT CORPORATION, with principal office address at Corporate Office Building, Civil Aviation Complex, Clark Freeport Zone, Pampanga, Philippines, herein represented by its Officer-in-charge, **Ms. NANCY C. PAGLINAWAN**, duly authorized to enter into this Agreement (hereafter referred to as "Entity");

And

WE LINK MANPOWER SERVICES, with principal office address at 2nd Avenue, Unisite Subd., Barangay Del Pilar, City of San Fernando, Pampanga, Philippines, herein represented by **Ms. ADRIENNE THERESA Z. DIZON**, duly authorized to enter into this Agreement (hereafter referred to as "Supplier")

WHEREAS, the Entity expressed its intention to renew the contract with the Supplier, particularly the Contracting of Janitorial Services for CIAC CY 2023, and has accepted the affirmation of the Supplier for the supply of those goods and services in the sum of **FIVE HUNDRED FORTY TWO THOUSAND ONE HUNDRED FIFTEEN PESOS AND 88/100 ONLY (PHP542,115.88)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, *viz.*:
 - I. Supplier's eligibility requirements;
 - II. Performance Security;
 - III. Notice of Renewal; and the Bidder's conforme thereto; and
 - IV. Other contract documents that may be required by existing laws and/or the Procuring Entity. Supplier agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, shall likewise form part of the Contract.



3. In consideration for the sum of **FIVE HUNDRED FORTY TWO THOUSAND ONE HUNDRED FIFTEEN PESOS AND 88/100 ONLY (PHP542,115.88)** or such other sums as may be ascertained, We Link Manpower Services agrees to provide the goods and services in accordance with this contract renewal.
4. The duration of the contract will be from **November 1, 2023 to December 31, 2023.**
5. The Clark International Airport Corporation agrees to pay the above-mentioned sum in accordance with the terms of this contract renewal.
