

# CONTRACT AGREEMENT FOR THE CONTRACTING OF THE SERVICES OF SEVENTY-SEVEN PRIVATE SECURITY AGENCY (PSA) GUARDS

This Agreement, made this DEC 29 2023 day of \_\_\_\_\_ 2023 between:

**CLARK INTERNATIONAL AIRPORT CORPORATION**, with principal office address at Corporate Office Building, Civil Aviation Complex, Clark Freeport Zone, Pampanga, Philippines, herein represented by its Officer-in-charge, **Ms. NANCY C. PAGLINAWAN**, duly authorized to enter into this Agreement, as evidenced by the Secretary's Certificate containing Board Resolution No. RM-05-04 Series of 2023, dated 26 May 2023 (hereafter referred to as "Entity");

And

**888 GALLANT SECURITY SERVICES CORPORATION**, a corporation organized and registered with the Securities and Exchange Commission, and existing under the laws of the Republic of the Philippines, with principal office address at 558-A Quirino Avenue, Brgy. Tambo, Parañaque City, herein represented by **Mr. DAVID I. BALAONG**, duly authorized to enter into this Agreement (hereafter referred to as "Supplier")

WHEREAS, the Entity expressed its intention to extend the contract with the Supplier, particularly the **Contracting of the Services of Seventy-Seven Private Security Agency (PSA) Guards**, and has accepted the affirmation of the Supplier for the supply of those goods and services in the sum of **SIX MILLION TWO HUNDRED FORTY FIVE THOUSAND THREE HUNDRED EIGHTY AND 62/100 ONLY (PHP6,245,380.62)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, *viz.*:
  - I. Supplier's eligibility requirements;
  - II. Performance Security;
  - III. Notice of Extension; and the Bidder's conforme thereto; and
  - IV. Other contract documents that may be required by existing laws and/or the Procuring Entity. Supplier agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution,

such as the Notice to Proceed, shall likewise form part of the Contract.



In consideration for the sum of **SIX MILLION TWO HUNDRED FORTY FIVE THOUSAND THREE HUNDRED EIGHTY AND 62/100 ONLY (PHP6,245,380.62)** or such other sums as may be ascertained, **888 GALLANT SECURITY SERVICES CORPORATION** agrees to provide the goods and services in accordance with this contract renewal.
4. The duration of the contract will be from **January 01, 2024 to February 01, 2024.**
5. The **CLARK INTERNATIONAL AIRPORT CORPORATION** agrees to pay the above-mentioned sum in accordance with the terms of this contract renewal.


