

**INVITATION TO BID FOR  
CONTRACTING OF SERVICES FOR THE MAINTENANCE OF  
157.82 HECTARES CIAC LANDSIDE SODDED GROUNDS**

1. The Clark International Airport Corporation (CIAC), through the Corporate Budget of CY 2024 intends to apply the sum of **Nine Million Nine Hundred Twenty-Six Thousand Pesos (Php 9,926,000.00)** VAT inclusive being the ABC to payments under the contract **Contracting of Services for the Maintenance of 157.82 Hectares CIAC Landside Sodded Grounds** [CIAC-BAC-Goods-P75]. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Clark International Airport Corporation now invites bids for the above Procurement Project. The contract duration is ten (10) months commencing March 1, 2024 to December 31, 2024. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "*pass/fail*" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from the CIAC-BAC and inspect the Bidding Documents at the address given below from 8:00 am to 5:00 pm, Monday to Friday.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **January 24, 2024 until the deadline of the Submission of Bid** from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Ten Thousand Pesos (Php10,000.00). The Procuring Entity shall allow the bidder to present its proof of payment for the bidding document fee in person or through the electronic mail as provided below
6. The **CIAC-BAC** will hold a Pre-Bid Conference on **January 31, 2024 (Wednesday), 10:00am** at the CIAC Corporate Office Building, Clark Freeport Zone, Pampanga and through video conferencing via Zoom application which shall be open to prospective bidders. Prospective bidders who are interested to participate



in the Pre-Bid conference shall inform the CIAC-BAC and coordinate with the BAC Secretariat through the email address provided below.

7. Bids must be duly received by the BAC Secretariat through manual submission at the **Records Management Division, Corporate Office Building, Civil Aviation Complex, Clark Freeport Zone**, on or before **February 12, 2024 (Monday), 10:00am** Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be on **February 12, 2024 (Monday), 10:15am** at the **CIAC Corporate Office Building, Civil Aviation Complex, Clark Freeport Zone** and through video conferencing via Zoom Application. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The **CIAC** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.

Each Bidder shall submit one (1) original and two (2) certified true copies of its bid.
